## About Secretary of State Hillary Clinton

Hillary Diane Rodham Clinton is an American politician who served as the 67th United States Secretary of State under President Barack Obama from 2009 to 2013. She is the wife of the 42nd President of the United States Bill Clinton, and was First Lady of the United States during his tenure from 1993 to 2001. Clinton subsequently served as a United States Senator from New York from 2001 to 2009, and is a candidate for President of the United States in the 2016 presidential election.

A native of Chicago, Illinois, Hillary Rodham graduated from Wellesley College in 1969, where she became the first student commencement speaker. She went on to earn her J.D. from Yale Law School in 1973.

After moving to New York, Clinton was elected in 2000 as the first female senator from the state, the first and so far only First Lady ever to have sought elected office. Following the September 11 attacks, she voted for and supported military action in Afghanistan and the Iraq Resolution, but subsequently objected to the George W. Bush administration's conduct of the Iraq War, as well as most of Bush's domestic policies. Clinton was re-elected to the Senate in 2006. Running for the Democratic nomination in the 2008 election, Clinton won more primaries and delegates than any other female candidate in American history, but lost the nomination to Barack Obama.

As Secretary of State in the Obama administration, Clinton was at the forefront of the U.S. response to the Arab Spring and advocated the U.S. military intervention in Libya. She took responsibility for security lapses related to the 2012 Benghazi attack, which resulted in the deaths of American consulate personnel, but defended her personal actions in regard to the matter. She encouraged empowerment of women everywhere and used social media to communicate the U.S. message abroad. Leaving office at the end of Obama's first term, she authored her fifth book and undertook speaking engagements before announcing her second run for the *Democratic nomination in the 2016 presidential election in April 2015*.

## Public Financial Disclosure

The Ethics in Government Act of 1978, as amended, requires senior officials in the executive, legislative and judicial branches to file public reports of their finances as well as other interests outside the Government. The statute and the U.S. Office of Government Ethics's (OGE) regulations specify which officials in the executive branch file an OGE Form 278. Unlike confidential financial statements filed by some mid-level employees, the OGE 278 is available to the public. Reviewing officials within each agency certify and maintain these reports. Agencies do, however, forward reports of Presidential appointees confirmed by the

Senate and certain other reports to OGE for additional review and certification.

## **OGE Form 278**

The purpose of this report is to assist employees and their agencies in avoiding conflicts between duties and private financial interests or affiliations. Agency ethics officials will use the information filers provide to determine whether any potential conflicts exist. The form also will be made available if it is requested by a member of the public. Public requesters are prohibited, however, from using the information on an individual's form for any unlawful or commercial purpose, or from using it as a basis to establish a credit rating or to solicit any money from the filer.

## **Report Completeness**

A presidential candidate may report asset values in wide ranges. In addition, a candidate's federal plan, homes, and cars are not required to be on the report. Members of congress are not required to disclose stock transactions in the last 45 days or titleholders on their mortgages.
